**CRITERIA FOR ELIGIBILITY**

1. Be enrolled in a degree-bearing program (matriculated).
2. Be registered for at least 6 credits (at least 3 of the 6 must be college-level credits).
3. Have already accrued 3 credit hours at SUNY Orange or at another accredited institution (academic transcript of course work completed at a prior institution should be submitted to the Office of Financial Aid).
4. Have a minimum cumulative grade point average of (at SUNY Orange) 2.0 and must meet N.Y.S. academic requirements.
5. Be a New York State Resident.
6. Fall within the following income limits:
  - a. INDEPENDENT (not claimed as a tax dependent by parents)
    - Single or Married (NO DEPENDENTS)  
N.Y.S. NET TAXABLE INCOME CANNOT EXCEED \$34,250
    - Single or Married (WITH DEPENDENTS)  
N.Y.S. NET TAXABLE INCOME CANNOT EXCEED \$50,550
  - b. DEPENDENT (claimed by parents as tax dependent)
    - N.Y.S. NET TAXABLE INCOME OF STUDENT, SPOUSE AND PARENTS  
\$50,550 OR BELOW.
7. Submit SIGNED COPY of your (and your parents, if dependent) 2010 N.Y.S Tax Return. Those not filing a N.Y.S. tax return must submit a signed copy of their Federal Tax Return. If no tax return was filed in 2010, a statement advising us that you and/or your parents were not required to file tax returns must be submitted with the application.

**REMINDER: EARLY APPLICANTS GIVEN PRIORITY CONSIDERATION.**

1. Due to funding limitations and the increased number of qualifying applicants, funding is limited to coverage of 6 credit hours regardless of enrollment status. The only exception to coverage is if student needs less than 6 credits to graduate.
2. Students awarded New York State Aid-To-Part-Time Study (APTS) must complete a minimum number of college credits (based on NYS Academic Regulations) and maintain a 2.0 or higher GPA and CQPA in order to be eligible to receive APTS the following semester.
3. Finalization of Fall and Spring APTS awards cannot be guaranteed to meet tuition payment deadlines. You may want to make other arrangements for payment and be reimbursed at a later date. Please note that the timing of APTS reimbursements are subject to SUNY Orange=s receipt of funds from NYS.
