- 5. define anxiety (Nursing I).

- 7. identify the health needs and concerns of each adult age group.
- 8. identify defense/coping mechanisms used by hospitalized clients. Differentiate between effective and ineffective coping (Nursing I).

- 9. explain multiple aspects of chronic diseases.
- 10. explain the physical response to stress and the effect on the immune system
- 11. define HIV and the immune response
- 12. discuss hypersensitivity- primary and secondary response
- 13. differentiate between tolerance and dependence.
- 14. define alcoholism and the addictive personality.
- 15. discuss the etiological factors in the development of alcoholism.
- 16. identify patterns of behavior associated with alcoholism.
- 17. identify the factors that have a negative impact on self-esteem and lead to patterns of chemical dependency.
- 18. use the nursing process to plan care during the acute stages of treatment for the client with alcohol dependency.
- 19. assess the needs of the client with alcohol withdrawal.
- 20. prioritize nursing care to keep clients safe when they are in alcohol withdrawal.
- 21. identify nursing interventions for the client with alcohol dependency needs.
- 22. discuss the behavior characteristic of co-dependency as seen in adult children of alcoholics.
- 23. use the nursing process to plan and care for the client with alcohol dependency needs.
- 24. identify nursing responsibilities toward the client involved in an alcohol treatment program.
- 25. describe the potential discharge needs of the client with alcohol dependency.
- 26. evaluate one's view of chemical use and dependency.
- 27. explain the responsibilities of the nurse when a peer is suspected of abusing or misusing substances.
- 28. demonstrate the nursing process with rationale to plan client care.
- 29. demonstrate the administration of a primary intravenous to a client.
- 30. demonstrate previously learned clinical skills.
- 31 calculate the flow rate of an intravenous infusion for a client.
